PUBLIC NOTICE IS HEREBY GIVEN THAT, the Planning & Zoning Commission of the Village of Romeoville, Will County, Illinois, (the “Village”) will be holding a PUBLIC HEARING in the Village Hall Board Room at 1050 W. Romeo Road, on December 12, 2023, at 6:00 PM or soon thereafter on the aforementioned date(s) for the purposes of considering testimony and other evidence on the following application for a Special Use Permit for a truck sales facility to operate in the M-1 Zoning District, which Romeoville Truck Sales, LLC has filed an application on or about September 21, 2023 with the Village of Romeoville, in accordance with the requirements described by the Romeoville Code of Ordinances, as amended, which governs such applications.

The property which is the subject of the “Application” is generally located as follows: 8 Greenwood Drive, and legally described as follows:

A PORTION OF BLOCK 4 IN HAMPTON PARK INDUSTRIAL DISTRICT, A SUBDIVISION OF A PORTION OF THE SOUTH 1/2 OF SECTION 27, AND A PORTION OF THE NORTHWEST 1/4 OF SECTION 34, TOWNSHIP 37 NORTH, RANGE 10, EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED JUNE 28, 1960, IN PLAT BOOK 32, PAGE 67, AS DOCUMENT NO. 906784, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGINNING AT THE SOUTHEASTERLY CORNER OF SAID BLOCK 4; THENCE SOUTH 89 DEGREES 00 MINUTES 50 SECONDS WEST ALONG THE NORTHERLY LINE OF GREENWOOD AVENUE, A DISTANCE OF 761.43 FEET; THENCE NORTH 0 DEGREES 56 MINUTES 40 SECONDS EAST, A DISTANCE OF 315.19 FEET; THENCE NORTH 89 DEGREES 00 MINUTES 50 SECONDS EAST A DISTANCE OF 758 FEET TO A POINT ON THE WESTERLY LINE OF PARKWOOD AVENUE; THENCE SOUTH 0 DEGREES 19 MINUTES 15 SECONDS WEST ALONG THE WESTERLY LINE OF SAID PARKWOOD AVENUE, A DISTANCE OF 315.08 FEET TO THE POINT OF BEGINNING, IN WILL COUNTY, ILLINOIS.
