### **Call to Order:**

At 6:31 PM the regular meeting of the Board of Fire & Police Commissioners was called to order by Chairman Thomas Herbst. The meeting was held in conference room V119, Romeoville Village Hall, 1050 West Romeo Road, Romeoville, Illinois.

### **Roll Call:**

Upon roll call, the following were present: Chairman Thomas Herbst, Commission Secretary John Frangella, Commissioner Ken Burgess, Commissioner Jorge Moreno and Commissioner Christine Venn. ### **New Business:**

Dawn Caldwell, Village Manager, told the Commission the Firefighter salary was raised from \$84,000 to \$114,000 by the Village Board.

Chief Hromadka discussed the new Bill (Sonya Massey Bill) for backgrounds, companies are required to supply a written letter of employment for each police applicant (entry and lateral police candidates).

Chief Hromadka states that probably in 3 months we will be doing another sergeant test. Candidates can take the test as long as they are 1 year off probation.

Review other personnel in executive session and candidates' medical reports.

The date and times for the firefighter oral interviews will be on October 27, 2025, from Steve Hale with Resource Management, with the first group at 6 p.m., second group at 7 p.m., third group at 8 p.m., and the last group at 9 p.m. All Commissioners except Christine Venn can attend, therefore, we have a quorum. Resource Management Associates is administering the Firefighter Orals, and the Commissioners will just be observing the process.

Commission Secretary Frangella was aware that the regular meeting for November 11, 2025 falls on Veterans Day. After further discussion, the commission voted to change the meeting to Wednesday, November 12, 2025 at 6:30 p.m. He will send a meeting change notice as required.

### **Motion to close regular meeting (move to executive session)**

At 7:13 p.m. a motion was made by Commissioner Burgess and seconded by Commissioner Moreno to go into Executive Session. All ayes, motion carried.

### **7:42 p.m. Return to Regular Meeting**

Patrolman Eric LeStronge was promoted to sergeant tonight by the Commission and his start date for this position with the Police Department will be later determined.

### **Adjournment:**

At 8:00 p.m. a motion by Commissioner Burgess to adjourn was made, second by Commissioner Venn. Voted on, all ayes, motion passed.
